- To promote risk-based thinking, address risk and opportunities in all of our activities.
- To promote the health and wellbeing of all personnel.
- To prevent any accidents.
- To minimize the impact on the environment from our activities.
- To achieve and maintain a level of quality which enhances the Company's reputation with customers.
- To ensure compliance with relevant statutory, safety and contractual requirements. Additionally, we will adopt a strict ethical behaviour and sound professional judgment in all our activities.
- To endeavour, at all times, to maximize customer satisfaction with the products and services provided.
- To protect and prevent unauthorised access to the company's IT system.

We will integrate the following governing principles in all our activities:

• Human rights, Business ethics and Sustainability. SubseaDesign shall conduct its business in accordance with the principle of sustainable development and shall adhere to internationally recognized fundamental standards for occupational health and safety, environmental protection, child labour and human rights as well as responsible corporate governance. Any risks compromising our long-term viability will be identified and handled. This includes risks related to the context of the organisation.

- Competency. We will continuously develop and improve our employees' knowledge and skills through training, guidance and appropriate tools to ensure that they fully implement this QHSE philosophy and to ensure that they keep the required level of professional knowledge to carry out their work in our knowledge-based organisation.

Computer based systems are the main working tools for SubseaDesign's activities and are managed and monitored with high degree of Confidentiality, Integrity and Availability.
